Series 2 –1842-1899**

The Australian Biographical & Genealogical Record was established in the early days of computing in 1982 with the aim of creating a biographical database of every person born in or arriving in Australia from 1788 to about 1900. It was the direct ancestor of this website.

ABGR published transcripts of musters from the early colonies of NSW, Tasmania and Norfolk Island during 1987-1999, all of which are now included on BDA.

ABGR also published a series of biographical dictionaries as *Australian Biographical & Genealogical Record* (Series 1, Series 2, 1985-1992). The contents of these biographies of ancestors contributed by their descendants and researchers have been included on BDA.

Series 2 was published first, in three volumes in 1985, 1987 and 1988 respectively. Each contained short biographies of persons who were born in or arrived in Australia in the period 1842-1899.

The title page of the volumes (apart from giving the volume number) reads:

Australian Biographical and Genealogical Record – Series 2 – 1842-1899,  
Edited by Kenneth J. Cable & Jane C. Marchant, Published by A.B.G.R. in  
association with the Society of Australian Genealogists, Sydney.

Contributors to the ABGR Project were asked to fill in a Biographical Detail Form (BDF) with basic information about individuals, including names, dates of birth, marriage and death, ship and year of arrival, parents and children of those persons. The original BDF forms and associated material are housed in the Manuscripts collection of the Society of Australian Genealogists at 120 Kent Street, Sydney. The entries on BDA give a source reference number to the files in that collection. The files for published biographies may contain additional material, including the original wording and correspondence of the contributor and sometimes different photographs to those published.

The contents of those published biographies are now on BDA in two separate Datasets. Apart from these three volumes, a supplement containing many biographies for this time period was published at the end of the Series 1 volume in 1992. The total number of biographies in these three volumes and the supplement total 4135. These biographies have not been fully cross indexed as yet, but married and single names of female subjects and aliases are indexed and result in a final total of 5282 entries.

The Explanatory Notes and Abbreviations sections in the following pages taken from the book should be consulted to understand the background to the wording in the biographies.

### Explanatory Notes

#### Key to Biographies:

Each Biography contains some or all of the following information in the following order -

Surname, Given Name(s), (birth-death years), occupation, primary place of abode; birth date and place; baptism/naming date, religion, place; father's full name, occupation, abode and mother's given name(s) (maiden name) and occupation; subject's education, subject's employers, place of arrival in Australia, date, ship and status of subject; date joined military, place, regiment, rank, war service and discharge date; land acquired, area, date, locality; name of spouse (birth-death years), father's name and abode and mother's given name(s) (maiden name); date and place of marriage, church name and religion; issue of subject - given name(s), (birth-death years), (married name of female children).

The second and subsequent paragraphs contain additional biographical material ending with the subject's date and place of death and burial.

Further biographical references may then appear in round brackets. A reference number appears in square brackets at the end of each biography. The first four numerals identify the Contributor - listed in the back of the volume, the number following refers to the subject's registration number, as submitted by the contributor.

#### Format of the Biographies:

The first paragraph of each biography follows the above sequence. This sequence was chosen to enable the information to form part of a computer data base. Each subject is

treated as an individual, thus, in instances where spouses also appear in the volume, some information will be duplicated.

### Personal Names:

Subjects appear under the name by which they were known on arrival in Australia. Therefore all females born in Australia will appear under their maiden names. Any subsequent married names have been cross referenced.

Where spelling variations appear in surnames, this may be a reflection of differences in various records or because of a deliberate change made by the subject during their lifetime or between generations.
