Colonial Secretary NSW, index to letters to Sheriff 1828-1850.

The Office of Sheriff of New South Wales (formerly known as the Provost Marshal) was established in 1824. The Sheriff's tasks included:

-) executing all judgments, decrees and orders of the Supreme Court
-) carrying out executions and sentences imposed by criminal courts
-) managing gaols, convict ironed gangs, arranging transport of convicts to and from gaols and penal settlements
-) acting as Coroner and Marshal of the Admiralty

As the colony's chief public servant, the Colonial Secretary sent letters to the Sheriff directing him to carry out his duties. This dataset indexes persons mentioned in the copies of letters sent: mostly police, gaol and court employees, convicts and other prisoners, including court witnesses, officials, soldiers, doctors, lawyers, crew, shipping and transport contractors.

Indexed fields include name and (where available) occupation, place of residence or destination, ship of arrival, regiment, ethnicity (including some Aboriginal people) and in the remarks column a brief summary of the content of the letter.

This can be particularly useful, giving the name of the gaol or penal settlement to which a convict was being sent (at this period often Hobart, Port Macquarie, Moreton Bay or Norfolk Island). Sydney's Gaol and Hyde Park Barracks are often mentioned. Other letters mention families of convicts or prisoners, petitions for mitigation of sentence and convicts received from other colonies.
